- 1. This order has arisen out of the MA/21/KOB/2020 filed under Section 22(3)(b) read with Section 60(5) of IBC, 2016 by the Committee of Creditors for replacement of the Interim Resolution Professional in TIBA/3/KOB/2019.
- 2. This Tribunal vide order dated 28.11.2019 admitted the application filed by the Financial Creditor and initiated Corporate Insolvency Resolution Process against the Corporate Debtor and appointed Shri Navneeth Vasudevan as Interim Resolution Professional.
