2. KEY DEFINITIONS

- 2.1. **“Adjudicating Authority”** or **“NCLT”** shall mean the Hon’ble Chandigarh Bench of the National Company Law Tribunal;
- 2.2. **“Applicable Laws”** shall mean, all the applicable laws, codes, regulations, rules, guidelines, circulars, re-enactments, revisions, applications and adaptations thereto, judgments, decrees, injunctions, writs and orders of any court, arbitrator or governmental agency or authority, rules, regulations, orders and interpretations of any governmental authority, court or statutory or other body applicable for such transactions including but not limited to the Insolvency and Bankruptcy Code, 2016 and relevant regulations, circulars, notifications, Companies Act, 1956 / 2013 (as applicable), Competition Act, 2002, Transfer of Property Act, 1882, Sale of Goods Act, 1930, Foreign Exchange Management Act, 1999, whether in effect as of the date of this E-Auction Process Information Document or thereafter and each as amended from time to time;
- 2.3. **“Bid”** means, any bid submitted by the Bidders as required in terms of this E-Auction Process Information

- 2.10. **“Liquidation Process Regulations”** means, the Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations 2016 as amended from time to time;
- 2.11. **“Liquidator”** means an insolvency professional appointed as a liquidator in accordance with section 34 of the IBC;
- 2.12. **“Person”** shall mean an individual, a partnership firm, an association, a corporation, a limited company, a trust, a body corporate, bank or financial institution or any other body, whether incorporated or not;
- 2.13. **“Qualified Bidder(s)”** shall mean a Bidder who fulfills the eligibility criteria listed out in the E-Auction Process Information Document.

BRIEF BACKGROUND

- 2.15. SRS Limited (Corporate debtor or the Company) incorporated in the year 2000 under the provisions of the Companies Act, 1956 and having its registered and corporate office located at 2nd Floor, SRS Multiplex, Sector-12, Faridabad, Haryana-121007. The Company is Listed on the Bombay Stock Exchange and National Stock Exchange of India since September 2011 under the name and style of ‘SRS Limited’. The company was earlier engaged in the business of Jewellery, Retail and Exhibition of Cinemas, However, at the initiation of CIRP only the business of Exhibition of Cinema was operational from 38 screens spread across 5 states and presently the Cinema business operations are stalled since the start of Lockdown imposed by Central Government. The Company owns certain real estate in Faridabad and in close proximity areas of Faridabad in Haryana.
- 2.16. The Company’s Liquidation Process has been initiated under the provisions of the Insolvency and Bankruptcy

Code, 2016 by an order of the NCLT, Chandigarh Bench with effect from 15th October, 2019. As per the said order, Ashok Kumar Gulla has been appointed as the Liquidator.

- 2.17. It is the endeavor of the Liquidator to sell the assets and properties comprising the liquidation estate of the Company in the manner specified under Regulation 32 of the Liquidation Process Regulations, any other rules, regulations, orders, circulars, directions or notifications or the like, issued pursuant to or under the IBC or the Liquidation Process Regulations, as the case may be, and as per directions, if any, of the NCLT in respect of the liquidation process of the Company and in the manner specified in this E-Auction Process Information Document.
- 2.18. The E-Auction would be conducted in the manner specified in Schedule I under Regulation 33 of the Liquidation Process Regulations, any other rules, regulations, orders, circulars, directions or notifications or the like, issued pursuant to or under the IBC or the Liquidation Process Regulations, as the case may be, and as per directions, if any, of the NCLT in respect of the liquidation process of the Company and in the manner specified in this E-Auction Process Information Document.
- 2.19. Certain assets of Corporate Debtor are covered by the provisional attachment order dated 08.01.2020 issued by the Enforcement Directorate. The matter has been pending before Hon'ble NCLT, Chandigarh Bench and the PMLA Adjudicating Authority. Those assets covered by the ED PAO have not been put for e-auction and thus are not considered for the purpose of this e-auction.
- 2.20. The E-Auction Participants are encouraged to make themselves acquainted with the provisions of the IBC and the Liquidation Process Regulations and any other rules, regulations, orders, circulars, directions or notifications or the like, issued pursuant to or under the IBC or the Liquidation Process Regulations, as the case may be.
- 2.21. The information provided in this E-Auction Process Document should be read together with the provisions of the Code and the Liquidation Process Regulations. In the event of a conflict between this E-Auction Process Information Document and the Code or the Liquidation Process Regulations, the provisions of the Code or the

Liquidation Process Regulations, as the case may be, shall always prevail.

SRS Omaxe (Gurgaon) Cinema site located at **Omaxe Mall, Sohna Road, Sec-49, Gurgaon-122001** having **two Screens** (2 in No.) and having **506 seats**. Assets consisting of Leasehold improvements, Projecting equipments, Plant and Machinery, Furniture & Fixtures, Office Equipments, Computer and other devices installed at the site that are owned by SRS Limited are put up for Auction. This Cinema is operated from leased premises and SRS Limited does not own the real estate property of this Cinema site, Hence, the Real estate property of the cinema is out of the purview of E-Auction.

This Cinema is operated from leased premises and SRS Limited does not own the real estate property of this Cinema site, Hence, the Real estate property of the cinema is out of the purview of E-Auction.

This Cinema is operated from leased premises and SRS Limited does not own the real estate property of this Cinema site, Hence, the Real estate property of the cinema is out of the purview of E-Auction.

This Cinema is operated from leased premises and SRS Limited does not own the real estate property of this Cinema site, Hence, the Real estate property of the cinema is out of the purview of E-Auction.

Assets consisting of Leasehold improvements, Projecting equipments, Plant and Machinery, Furniture & Fixtures, Office Equipments, Computer and other devices installed at the site that are owned by SRS Limited are put up for Auction. This Cinema is operated from leased premises and SRS Limited does not own the real estate property of this Cinema site, Hence, the Real estate property of the cinema is out of the purview of E-Auction.

Block 11:- SRS Bhiwadi Cinema (Franchisee Model)

SRS Bhiwadi Cinema site located at V Square Mall, Khasra No.489 – 490, Vill.- Saidpur, Teh. – Tijara, Dist. Alwar, Rajasthan-301019 having **three Screens** (3 in No.) and having **621 seats**. Assets consisting of Leasehold improvements, Projecting equipments, Plant and Machinery, Furniture & Fixtures, Office Equipments, Computer and other devices installed at the site that are owned by SRS Limited are put up for Auction. This Cinema is operated from leased premises and SRS Limited does not own the real estate property of this Cinema site, Hence, the Real estate property of the cinema is out of the purview of E-Auction.

- It is also disclosed that there are certain assets installed/embedded at the cinema sites which belongs to third party including but not limited to leased projectors, leased advertising equipment etc. belonging to third party and the ownership of these assets shall not be transferred. It is to be noted that 100% Equity shares of SRS Entertainment India Limited shall be transferred except 60 shares which are held by (i) Mr. Pratik Jindal, (ii) Mr. Abhishek Goyal, (iii) Mr. Ankush Goyal, (iv) Mr. Sunil Jindal, (v) Mr. Anil Jindal and (vi) Mr. Bishan Bansal (each shareholder holding 10 equity shares of SRS Entertainment India Limited in the capacity of nominee shareholder) in order to meet the minimum requirement of shareholders as mentioned in Section 187 of

the Companies Act, 2013, out of total of 2,66,60,000 equity shares.

SRS Entertainment India Limited is into the business of Exhibition of Cinemas and runs 12 screens out of 4 Location. The brief details of cinemas under SRS Entertainment India Ltd are provided as below:-

6.6. Declaration of Successful Bidder
